**1. TYPE II 2-20 SOUTH SUBURBAN SANITARY DISTRICT – SITE 1**

Consideration of a request to allow the irrigation of approximately 550 acres of agricultural land with Class D Recycled Water for the production of fodder crops such as alfalfa, grass hay or pasture; the construction of a 95 acre storage reservoir for Class D Recycled Water; the construction of a 6 mile long, 18-inch pipeline to carry recycled water from the treatment facility to the reservoir; and associated treatment facility upgrades. The subject properties for the irrigation are generally found east of Hwy 39, North of Short Road, East and West of Reeder Road and South of the OC&E Trail. The reservoir is located South of the OC&E Trail and West of Reeder Road. The pipeline will primarily follow the OC&E trail from the treatment facility to the proposed storage reservoir. The properties are zoned Exclusive Farm Use – Crops (EFU-C). **2. TYPE II 7-20 SOUTH SUBURBAN SANITARY DISTRICT – SITE 2**

Consideration of a request to allow the irrigation of approximately 750 acres of agricultural land with Class C to Class B Recycled Water for the production of fodder crops such as alfalfa, grass hay or pasture; the construction of a 88 acre storage reservoir for the Recycled Water; the construction of a 11 mile, 18-inch pipeline to carry recycled water from the treatment facility to the reservoir and associated treatment facility upgrades. The subject property is zoned Exclusive Farm Use – Crops / Grazing (EFU-CG) and located on the south side of North Poe Valley Road, approximately ¼ mile east of the intersection of North Poe Valley and HWY 140E.
