AMENDMENT #1 to
PRICE AGREEMENT# 5553

This is Amendment No. 1 (this "Amendment 1") to Contract # 5553 (as amended from time to time, the "Contract") dated 04/06/2015, between the State of Oregon, acting by and through its Department of Administrative Services, Procurement Service ("DAS PS") on behalf of the Oregon Authorized Purchasers, and Withnell Motor Company. (hereafter called "Contractor") for the provision of Automotive Vehicles. This Amendment is effective on the date it has been signed by every party and approved in accordance with applicable law.

1. The Price Agreement is hereby amended as follows:

- a. The contract is reinstated from the expiration date of December 31, 2015, due to an administrative error, upon completion of this executed amendment under the authority of the Department of Administrative Services, State Chief Procurement Officer.
- b. Language of Section 1.5.1 stating "...DAS PS may extend the term of the Price Agreement for up to five additional one year periods" shall be changed to read "...DAS PS may extend the term of the Price Agreement up to a total of five years."
- c. Per Section 1.5.1 the current ending, December 31, 2015 is hereby extended to March 31, 2020.

2. Except as expressly amended above, all other terms and conditions of the Price Agreement are still in full force and effect. Contractor certifies that the representations, warranties and certifications contained in the Price Agreement are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of execution of the Price Agreement.

Certification: By signature on this Contract for Contractor, the undersigned hereby certifies under penalty of perjury that the undersigned is authorized to act on behalf of Contractor and that Contractor is, to the best of the undersigned's knowledge, not in violation of any Oregon Tax Laws. For purposes of this certification, "Oregon Tax Laws" means a state tax imposed by ORS 320.005 to 320.150 (Amusement Device Taxes), 403.200 to 403.250 (Tax For Emergency Communications), 118 (Inheritance Tax), 314 (Income Tax), 316 (Personal Income Tax), 317 (Corporation Excise Tax), 318 (Corporation Income Tax), 321 (Timber and Forest Land Taxation) and 323 (Cigarettes And Tobacco Products) and the elderly rental assistance program under ORS 310.630 to 310.706 and any local taxes administered by the Department of Revenue under ORS 305.620.
