Background: The Board of County Commissioners held the first of two hearings on this matter on April 23, 2019. The second and final hearing was held today, May 21, 2019 at 8:45 a.m. No written requests for an election have been received. The petition has been endorsed by the Keno RFPD Board. The property subject to this request for withdrawal has a current contract with KCFD #1 for fire protection and has never received services from Keno RFPD; therefore the Board of Commissioners finds it feasible for the property to continue receiving fire protection services from KCFD #1.

WHEREAS, on April 2, 2019 by Resolution No. 2019-013, the Klamath County Board of Commissioners (BOCC) initiated the process to withdraw the property described in Exhibit A from the Keno Rural Fire Protection District (Keno RFPD); and

WHEREAS, the BOCC held the first hearing on April 23, 2019 at 8:45 a.m. and ordered a final hearing to take place today, May 21, 2019 at 8:45 a.m. for the taking of testimony and final consideration; and

WHEREAS, pursuant to ORS 198.810 (3), the BOCC allowed time for electors within the district to provide written requests for an election prior to today's hearing; and

WHEREAS, no written requests for an election were received and the petition for withdrawal has been endorsed by Keno RFPD by Resolution No. 19-001; and

WHEREAS, the BOCC has determined that the property subject to the withdrawal petition has not received services from Keno RFPD, but has and will continue to receive services from Klamath County Fire District #1 pursuant to a contract between the parties.

NOW, THEREFORE IT IS HEREBY ORDERED that the property described in Exhibit A is withdrawn from the Keno RFPD; and

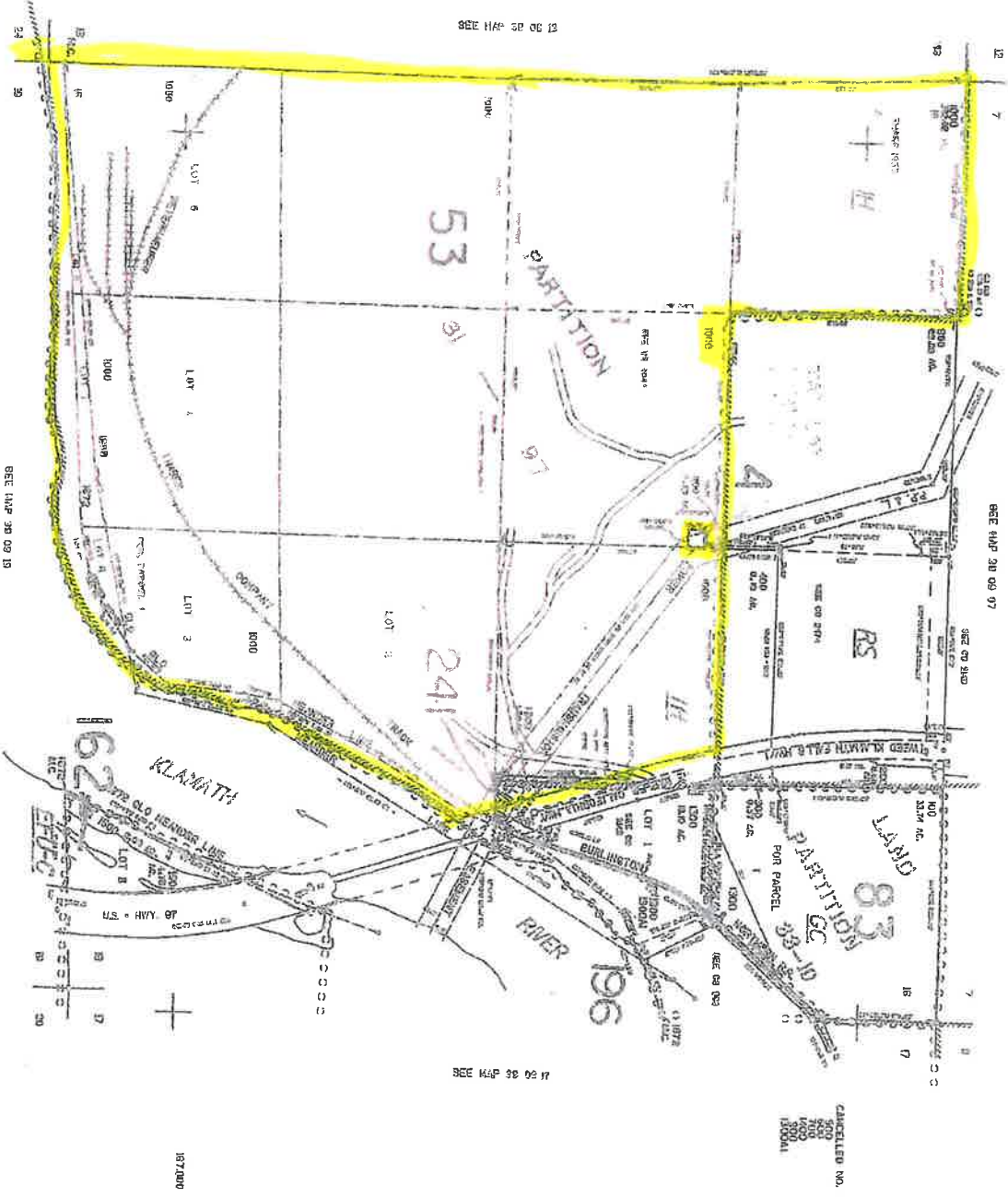
That portion of said Parcel 1 lying within said Section 18; containing 383 acres, more or less.
