Todd,

In speaking with Steve Jacques Assistant District Manager, it was decided to give a onetime verbal approval for the spot spraying along the Klamath Wing Watchers Trail on the west side of Lake Ewauna.

As discussed you will be spot spraying weed master and or mile stone with no perspective included in the treatment, you will not be impacting traffic along US 97 and it will be a onetime application based off a grant to the Wing Watchers group from the USFW. So at this point we will not require you to create an insurance policy with ODOT listed as additional insured but rather work under Klamath Counties ordinary insurance spray policy.
