Issue: In the Matter of Imposing and Categorizing Taxes of the Klamath County Extension Service District for Fiscal Year 2019-2020.

Background: The Klamath County Extension Service District budget for fiscal year 2019-2020 was adopted on June 18, 2019 for the fiscal year beginning July 1, 2019 that contains ad valorem tax at the rate of \$0.1500 per \$1,000 of assessed value for the General Fund. The Board of Directors is required to adopt a resolution imposing and categorizing tax for the tax year 2019-2020 upon the assessed value of all taxable property within the district boundaries.

Fiscal Impact: \$801,700 Estimated Ad Valorem Property Taxes for Fiscal year 2019-2020.

Recommended Motion: The Board of Directors hereby imposes the taxes provided for in the adopted budget at the rate of \$0.1500 per \$1,000 of assessed value for the tax year 2019-2020 upon the assessed value of all taxable property within the district effective July 1, 2019. The Board of Directors hereby categorizes the taxes as General Fund at the rate of \$0.1500 per \$1,000 of assessed value.

WHEREAS, the adopted fiscal year 2019-2020 budget contains ad valorem tax revenue requirements.
