S. COMMISSIONER REPORTS

1. COMMISSIONER MALLAMS – DISCUSSED UNVEILING THE SIGN. THANKED THE COMMUNITY FOR THE EFFORTS AND SAID THE SIGN LOOKED GREAT. HE SAID THE BOCC WENT UP TO CRESCENT LAST WEEK AND HAD THE PUBLIC MEETING UP THERE. HE SAID THERE WAS VERY GOOD ATTENDANCE AND GOOD DISCUSSION. HE CAME BACK WITH THREE ITEMS HE IS WORKING ON. HE SAID HE ATTENDED A MEETING AT SHILO INN ON MARIJUANA ISSUES. HE SAID IT WAS AN INTERESTING MEETING. HE LEARNED SOME NEW INFORMATION, THAT A MARIJUANA FARMER CANNOT USE FEDERAL WATER BUT THERE COULD BE EXCEPTIONS OR WAIVERS FROM THE BLM AND LOCAL WATER MASTER. HE SAID THE PROBLEM IS THERE IS NO SOLID RULES AND REGULATIONS AT THE STATE LEVEL. HE SAID HE HAS KEPT AN OPEN MIND. HE DOES NOT HAVE A PROBLEM WITH MEDICAL MARIJUANA IF IT IS REGULATED CORRECTLY. DISCUSSED THAT THE BOCC WILL HEAR RECOMMENDED MARIJUANA REGULATIONS FROM THE PLANNING COMMITTEE THIS EVENING. HE ATTENDED A FUNDRAISER FOR KCC SCHOLARSHIPS. IT WAS VERY WELL ATTENDED WITH A VERY ENTERTAINING COMEDY ACT. HE COMMENTED THAT HE ATTENDED OPERATION PROM NIGHT AT OIT YESTERDAY. HE SAID IT WAS A VERY POWERFUL EVENT.

COMMISSIONER BELLET – DISCUSSED GOING TO CRESCENT LAST WEEK AND THE SUCCESSFUL MEETING THERE. HE SAID THEY ARE TENTATIVELY SCHEDULING GOING TO EAST AND WEST COUNTY FOR PUBLIC MEETINGS AS WELL. HE SAID HE WENT TO SALEM FRIDAY FOR A BOARD OF FORESTRY MEETING. HE DISCUSSED THE 1.4 BILLION LAWSUIT LANE COUNTY HAS PROPOSED AGAINST THE STATE. HE ATTENDED THE KCC FOUNDATION FUNDRAISER AS WELL. HE ALSO ATTENDED THE MARIJUANA SEMINAR AT THE SHILO INN. HE SAID IT WASN'T AS WELL ATTENDED AS HE THOUGHT IT WOULD HAVE BEEN. YESTERDAY HE AND COMMISSIONER MORRIS WENT OUT TO HENLEY ELEMENTARY TO PLANT TREES FOR ARBOR DAY. HE SAID IT WAS THE BEST ATTENDED ARBOR DAY EVENT SINCE HE'S BEEN A COMMISSIONER BECAUSE THE WHOLE SCHOOL CAME OUT. HE SAID COMMISSIONER MALLAMS DIDN'T ATTEND BECAUSE HE WENT TO THE PROM NIGHT DEMONSTRATION AT OIT. THERE IS A PLANNING COMMITTEE HEARING TONIGHT IN WHICH THEY WILL DISCUSS THE PLANNING COMMISSION'S PROPOSED MARIJUANA REGULATIONS. HE SAID THE IN GOD WE TRUST PLAQUE IS VERY NICE AND THE ARTIST DID A GREAT JOB.

COMMISSIONER MORRIS – SHE SAID THAT IN THE PLANNING COMMISSION MEETING TONIGHT THERE WILL ALSO BE DISCUSSION ABOUT THE URBAN TRAILS MASTER PLAN. SHE SAID THE BOCC HAS FORMED A FOOD POLICY COUNCIL IN CONNECTION WITH THE BLUE ZONES PROJECT AND THEY ARE SEEKING APPLICANTS. THE FOOD POLICY COUNCIL WILL MAKE POLICY RECOMMENDATIONS TO THE BOCC.
