Issue: In the matter of accepting quote from Lithia Ford for two 2023 Ford pickup and authorizing Rick Vaughn, Code Enforcement Manager, to sign for the vehicles.

Background: Code Enforcement (CE) had teamed with the Klamath County Sheriff’s office to acquire four 4-door pickups from Emergency Responder Services in early 2022 with no delivery in site. New quotes were acquired as follows for delivery in the next 3-6 months:
 Lithia Ford – Klamath Falls \$48,857 + DMV, Taxes and fees
 Hall Ford – Lakeview \$47,865 + DMV, Taxes and fees
 Butler Ford – Ashland No quote

Recommending ordering from Lithia Ford to support local dealership.

CE has these funds budgeted from Marijuana Eradication Grant Fund.

Recommended Motion: Approve acceptance of quote for two 2023 Ford Pickups from Lithia Ford of Klamath Falls and authorize Rick Vaughn, Code Enforcement Mgr, to sign for vehicles. Fiscal Impact is an expenditure from the Marijuana Eradication Grant fund in the amount of \$97,714 + DMV, Taxes and fees.
