Last week the Board conducted additional days in union negotiations. We've also had some water issues to work on. He thanked Commissioner Boyd for his work out at the dam yesterday. The Board continued to advocate for water and agriculture and he appreciates that. He said, this morning the County buildings are open, we are taking precautions to make sure our employees are safe. He reminded the public to please try to conduct business by phone and email if they can. He also asked that the public maintain the CDC's social distancing guidelines. The Board will be working on submitting a plan to the Governor to reopen the county. He asked everyone to please be patient. The Board is fighting to get people back to work as soon as possible.

Commissioner Boyd - They've been working on employee contracts, most of the work is verbiage changes. He said, it is time to work on funding for our Sheriff's Department and public safety. He spent time at the headgates yesterday and thanked the BOR and Pacific Corp for adjusting down the flow. He also thanked Chief Henslee for being there all day.

Commissioner Morris - She and her colleagues have all been working toward a safe and responsible reopening plan for what is appropriate in this "new normal". They are working to come up with a plan that meets the needs of our county.

Commissioner Boyd - Encouraged businesses who are not on the list in the Governor's Executive Order to reopen.
