COMMISSIONER BELLET SAID HE HAD THE SAME QUESTION COMMISSIONER MALLAMS ASKED. HE ALSO ASKED IF THE RAILROAD HAD ITS OWN POLICE. SHERIFF STATED YES THEY DO BUT THEY ARE STRETCHED THIN. SHERIFF SAID THIS MAKES IT MORE HOMOGENOUS. COMMISSIONER MALLAMS QUESTIONED LANGUAGE IN THE CONTRACT "SUBMITTED AN ONGOING REQUEST". SHERIFF SAID IT WAS BASICALLY A MAN TO MAN AGREEMENT AND THIS CODIFIES IT. COMMISSIONER MALLAMS SAID HE HAS SOME RESERVATIONS. COMMISSIONERS BELLET AND MORRIS VOTE FOR. COMMISSIONER MALLAMS VOTES AGAINST. WE HAVE THE POTENTIAL OF LOSING POWER IN 8 STATES AND WE WANT TO MAKE SURE THE UTILITIES AND INFRASTRUCTURES ARE PROTECTED SO THE CITIZENS CAN GO ABOUT THEIR DAILY BUSINESS. HE SAID THIS IS A PROACTIVE APPROACH TO WORK TOGETHER TO BE ABLE TO PROTECT THESE PROPERTIES HAND IN HAND. HE SAID THEY ARE NOT UNIQUE IN THE COUNTRY AND THROUGHOUT THE WORLD. COMMISSIONER MALLAMS SAID HE DOESN'T THINK PUTTING THIS IN A FORMALITY WILL STOP ANYTHING FROM HAPPENING. HE SAID IT IS REDUNDANT AND THAT THE SHERIFF ALREADY HAS THE AUTHORITY TO PROTECT THE PROPERTY. COMMISSIONERS BELLET AND MORRIS VOTE FOR. COMMISSIONER MALLAMS VOTES AGAINST.
