**100.300 County Aid for Handicapped Persons and

**100.300 County Aid for Handicapped Persons and [Sheltered
Workshops] Rehabilitation Facilities.** The Board of County
Commissioners may budget to expend County funds for the aid of a
handicapped person in the County and for financial assistance to
[sheltered workshops] rehabilitation facilities, as defined in
O.R.S. 344.710, in the County.

100.700 Meetings of the Board of County Commissioners. The
Board of County Commissioners shall meet for the transaction of
County business on every [Wednesday] Tuesday in each month unless
otherwise scheduled by the Chairman of the Board and at such other
times as may be called by the Chairman of the Board.

**CHAPTER 102
FEES GENERALLY**

102.010 Statutory Fees. The County Clerk shall collect those
fees set out in O.R.S. 205.320, 205.323 and [~~205.325~~] 205.327.

102.020 Miscellaneous Fees. For any service which the Clerk
may be required by law to perform and no fee is provided by law,
such fees as may favorably compare with those established by this
section for similar services and as may be established by order or
rule of the Board of County Commissioners shall be collected.

102.030 Fee Schedule for Plats.

(1) For recording and indexing any plat, the County Clerk,
in whose office the deed records of the County are kept, shall
charge the fee as for recording a deed. [~~as follows:~~

~~(a) For plats containing 20 lots or less \$15.00;~~

~~(b) For plats containing over 20 lots, and less than 30 lots, \$20.00;~~

~~(c) For plats containing over 30 lots, and less than 50 lots, \$30.00;~~

~~(d) For plats containing over 50 lots, and less than 75 lots, \$30.00;~~

~~(e) For plats containing over 75 lots, and less than 100 lots, \$35.00;~~

~~(f) For plats containing over 100 lots, in addition to the charge of \$35, he shall make a charge of \$.35 per lot for all lots over 100.]~~

(2) Recording of Vacations Pursuant to O.R.S. 271.230. For recording in the County deed records, the County Clerk shall collect the fee as for recording a deed. For the services of County Surveyor for marking the record on the original plat, the County Clerk shall collect \$6.00 to be paid to the County Surveyor.

102.040 Fee Schedule for Mining Claims.

(1) Recording Copy of Location, Pursuant to O.R.S. 517.030. The locator shall, within sixty (60) days from the posting of the location notices by him upon the lode or claim, file for record with the Clerk for the county where the claim is situated, who shall be the custodian of miners' records and miners' liens, a copy of the notice posted by him on the lode or claim and pay the Clerk a fee as for recording a deed [~~of \$5.00 for such record~~], which sum the Clerk shall immediately pay over to the Treasurer of the County and shall take a receipt therefor, as in the case of other County funds coming into the possession of such officer.

(2) Recordation of Affidavit of Annual Labor Pursuant to O.R.S. 517.210. The fee for recording the affidavit is \$5.00.

(3) Certificate of Ownership Pursuant to O.R.S. 517.280. A Certificate of Ownership described in O.R.S. 517.280 shall not be issued until the co-owners entitled to it pay the Clerk a fee as for recording a deed [~~of \$5.00~~].

800.900 Schedule of Penalties.

(1) Violations are classified for the purpose of determining penalties in the following categories:

- (a) Class A violations.
- (b) Class B violations.

(2) An assessment of a penalty for a violation shall be an assessment to pay an amount not exceeding:


- (a) \$([~~600.00~~] **720.00**) for Class A violations;
- (b) \$([~~300.00~~] **360.00**) for Class B violations;

(3) For a continuing offense where only one citation is used, a fine of not more than \$1,000.00 may be assessed.
